December 2017

Water Quality Improvement Project

General Manager Sullivan, Utility Engineer Pritzlaff, and the Utility's attorney, Lawrie Kobza, attended the pre-hearing conference regarding the Water Quality Improvement project on December 6. Engineering coordinated with the various consultants including CH2M, CDM Smith, and Strategic Value Solutions, who have been working in support of the construction authorization application in order to ensure each of the items in the PSC's order to re-open the docket are addressed appropriately and completed to meet the above-mentioned deadlines.

**Drexel Ridge Phase II** 

All utilities have been installed. The sanitary sewer has been installed but still needs to be televised for final acceptance. The water main piping has been installed but remains un-filled due to unacceptable depth of cover over the main.

**IKEA Way Phase III** 

Approximately 1,600' of water main pipe is left to install before connecting to existing water main in South 27<sup>th</sup> Street. The water portion should be complete in approximately three weeks.

FedEx Development

The contactor has started the sanitary sewer portion of the project which entails offsetting the existing public sanitary sewer by approximately 10' in order to make room for the proposed building/loading dock. Water main work is on hold, because the WDNR has not approved the extension of water main.

### **DISTRIBUTION & COLLECTION OPERATIONS**

### December 2017

### Water Main Breaks:

On December 29<sup>th</sup> the Utility had a report of a main break at 8241 South Howell Avenue. A crew was sent to repair a 12" CIP. After excavating the main a circumferential break was found. The rest of the main looked in good shape. The main was installed in 1956.

### Water Lateral Repair:

There were no water lateral repairs in the month of December.

### **Hydrant Repair:**

There were no hydrant repairs in the month of December.

### Valve Repairs:

There were no valve repairs in the month of December.

### **Sewer Repairs:**

In the month of December Utility Workers performed 5 maintenance tasks including: grouting and installing a frame-to-chimney seal.

### Miscellaneous

In December the crews finished the inspection of the remote water and sewer mains.

In December the crews completed four water lateral taps, two were for new homes and two were for existing homes that were converting over to city water.

On December 6<sup>th</sup> Utility Service Workers Volbrecht, Price, Allard, Struebing, Pier, Maughan, Flatow, Proeber and Distribution Manager Schwartz attended bloodborne pathogen training.
