**A. Request to install "NO OUTLET" signs on Cardinal Circle.**

- a. Engineering described the request that was received by the Engineering Department. The requestor stated that during the summer they noticed vehicles traveling in the cul-de-sac that they didn't recognize on multiple occasions. There were 2 residents present from the area that did not support the request. The residents stated that over the past summer multiple (believe to be 3) homes were for sale and held open houses which they believe caused the increase unrecognizable vehicles. They believed that the installation of the sign was not a necessity. Engineering stated that they were not aware of the homes for sale with regular open houses. The traffic information taken during the prior week didn't indicate any increased volume than what would be expected with the number of homes in the cul-de-sac. The commission members agreed that installation of the sign would not be an appropriate improvement.

**B. Request to install "NO PARKING" signs at 6635 S. 21<sup>st</sup> Street.**

- a. Engineering described the request that was received by Patrick Gauthier on behalf of his parent that resides at 6635 S. 21<sup>st</sup> Street. There were 6 residents present from the area, 2 in favor of the request (residents at 6635) and 4 that opposed the request. The resident that resides at 6635 stated that the neighbor north of them park in front of their home which at times has caused the mail to not be delivered and refuse to not be picked up. They also stated that they spoke with the resident and that it didn't help. The other residents in the areas stated that her statements were false and that the resident at 6635 has lashed out at the neighbor to the north ever since they moved in. Commission members discussed the request and stated that no laws were being broken and parks cars did not create any traffic or safety issue. The commission members agreed that installation of the sign would not be an appropriate improvement.

**C. Request to improve pedestrian crossing at 340 E. Parkway Estates Drive.**

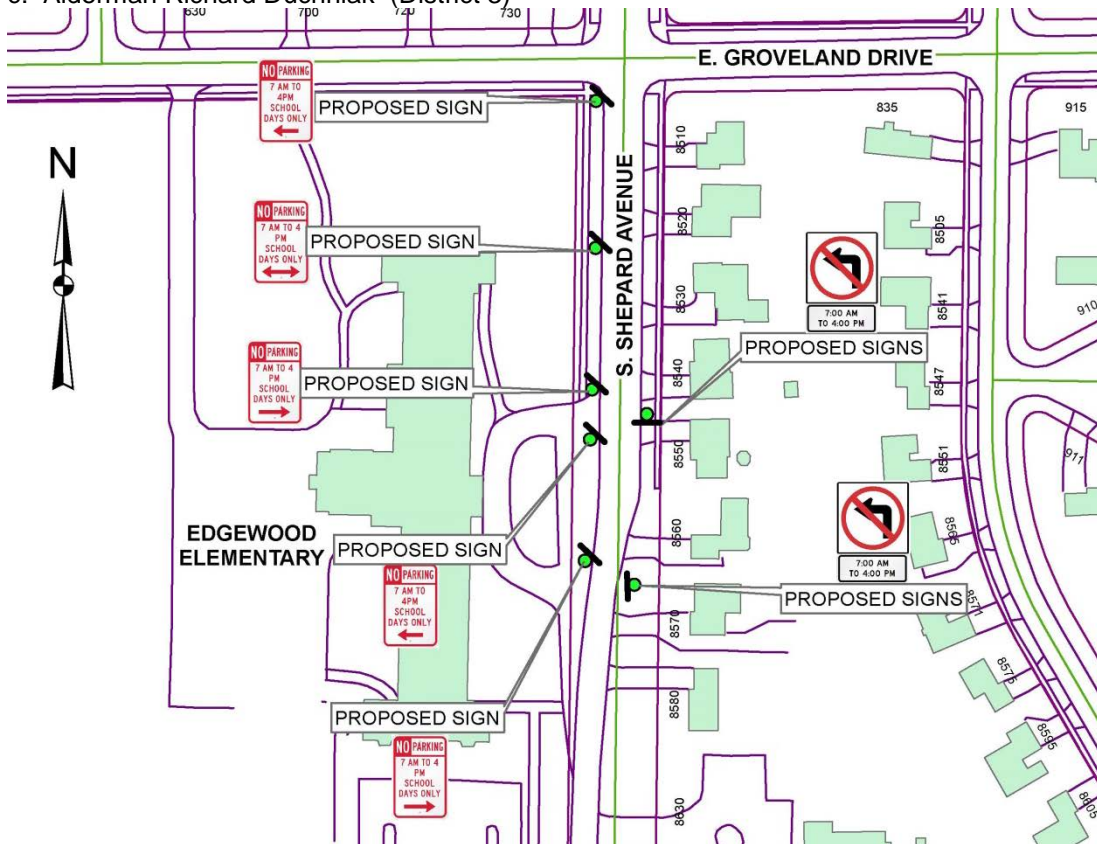
This meeting will be open to the public and you are invited to attend so that opinions, questions, and concerns regarding this issue may be expressed.

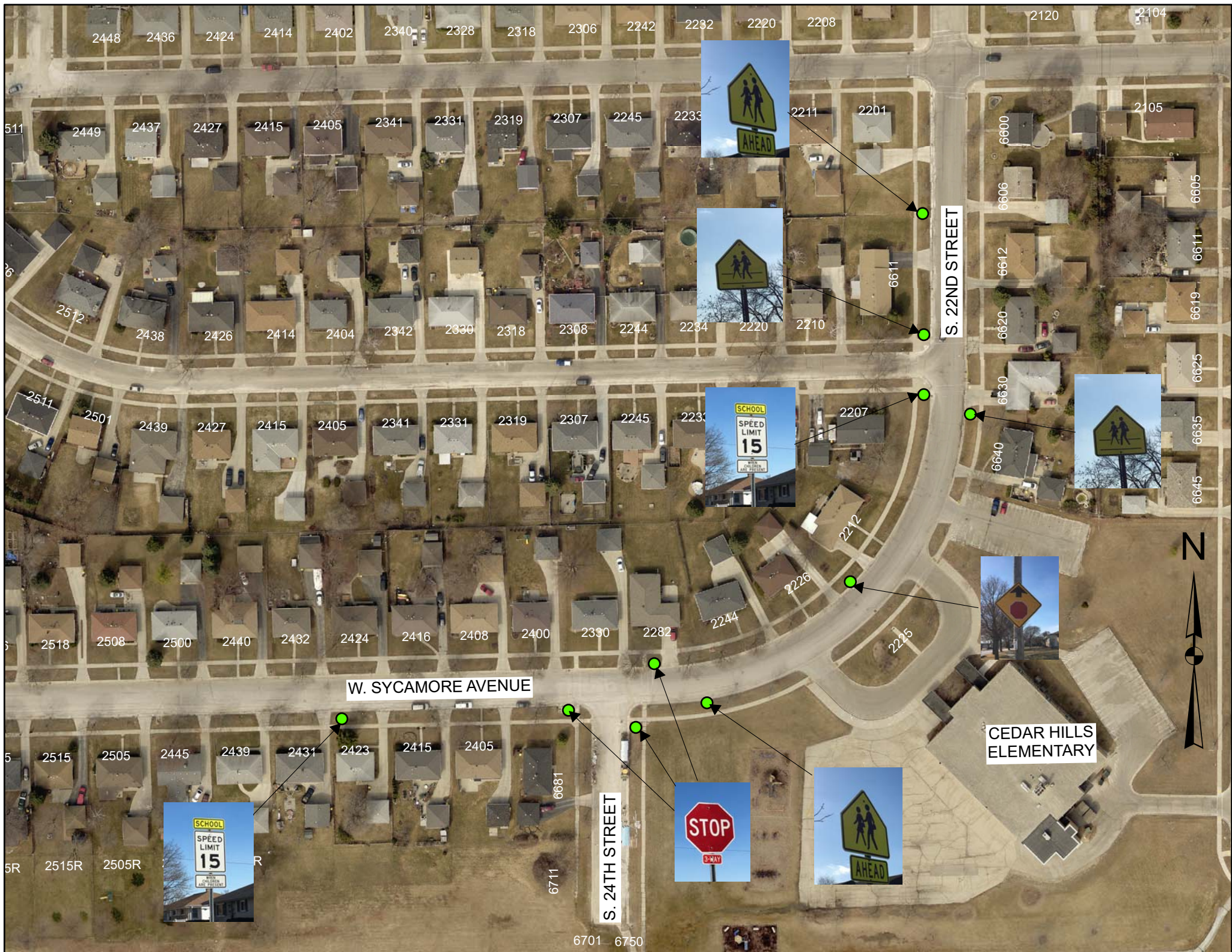
