
1. Call to Order by J. Avila at 4:00pm.
2. Roll Call: Those in attendance include J. Avila, R. Barribeau, D. DuBois, M. D'Amico, D. Pittman, G. Hintz, and S. Kurkowski. D. Ewing Decker arrived at 4:02pm. Guests in attendance include Rosemarie Annonson, Abbie Van Handel, and Anne Barberena.
3. Approval of Minutes from 05.03.2018: Motion to accept minutes as written made by M. D'Amico and seconded by R. Barribeau. All voted aye.
4. Health Officer Updates
  - Health Department report reviewed. D. DuBois highlighted Freedom on Wheels event and communicable disease activity.
5. Environmental Health Updates
  - D. DuBois provided update on We Energies. Mitigation efforts are underway; implementation will continue through 2019. Health Department has been in contact with Wisconsin Departments of Health Services and Natural Resources who report no ongoing concerns at this time. Resident voiced concern that air monitoring data released by We Energies is averaged and may not indicate if air quality is bad for a short period of time.
  - D. Pittman provided Sanitarian update. Inspections are going well; only one facility currently in need of inspection, which will be completed once they are in operation. Inspections of pools have been challenging as pools have not been inspected since 2016. Several pools have been temporarily closed due to violations. D. Pittman reported that updates have been made to address previously identified issues with elementary school kitchens.
6. Old Business
  - E-cigarettes – D. DuBois presented draft e-cigarette ordinance, which will be presented at the Common Council on 8.6.2018. Motion to approve draft ordinance as written made by S. Kurkowski and seconded by R. Barribeau. All voted aye.
7. New Business
  - Reproductive Health Services – D. DuBois provided overview of opportunity for Health Department to partner with Healthcare Education and Training to utilize grant funding to implement dual protection reproductive health services, including health insurance eligibility

screening/enrollment, sexually transmitted infection screening and treatment, pregnancy testing, initial supply of primary birth control method, and referral and follow-up. Follow-up discussion included concerns about confidentiality of minors' reproductive health care and potential benefits to community. Motion to allow Health Department to continue to pursue partnership with Healthcare Education and Training and grant opportunity for dual protection services and provide updates to Board of Health as needed made by R. Barribeau and seconded by D. Ewing Decker. All voted aye.
