RETURNING 2018 VENDOR

Vendors are not automatically accepted to market and will be reviewed by committee. Returning vendors who had contracts prior to January 15, 2018 are eligible for a waived fee for 2019.

The Oak Creek Farmers Market Committee approves each vendor. If you are accepted, you will receive an invoice from the City of Oak Creek.

There is typically no electrical access for vendors; however, there may be limited sites available for the 2019 season. A request would have to be made to the Farmers Market Committee; upon approval, a seasonal usage fee may apply.
