

MINUTES
LICENSE COMMITTEE
March 26, 2019 at 8:30 a.m.

1. The meeting was called to order at 8:30 a.m.
2. On roll call, the following committee members were present: Ald. Kurkowski, Ald. Duchniak and Ald. Gehl. Also in attendance was City Clerk Catherine Roeske, and Deputy City Clerk Christa Miller.
3. Ald. Gehl, seconded by Ald. Duchniak, moved to approve the minutes of 1/18/19. On roll call, all voted aye.
4. The Committee reviewed an original application for an Operator's license submitted by Jennifer K. K. Smith, 2100 Georgia Ave., Racine (Sidetracked). Ms. Smith was in attendance.

On her application, Ms. Smith indicated a 2007 OWI and a 2016 Driving While Revoked.

In addition to the convictions disclosed, a police record check showed that Ms. Smith had two Disorderly Conduct convictions (2003, 2004).

The Committee discussed the disclosures and omissions, noting the fact that the omitted offenses were from 15+ years ago, and that had they been disclosed, would not have prevented Ms. Smith from obtaining her license.
