

## Oak Creek Police & Fire Commission Meeting Minutes

### **Item One: Call Meeting To Order**

President Scott Koenig called the meeting of the Oak Creek Police and Fire Commission to order on Thursday, November 21, 2019 at 1800 hours at the Oak Creek City Hall, 8040 S. 6<sup>th</sup> Street, Oak Creek, WI.

### **Item Two: Roll Call**

The following Commissioners were present: Jesus Carrillo, Scott Koenig and Dennis Laskaskie. Commissioners Jeff Sageser and Jim Schultz were excused. Also in attendance were Fire Chief Mike Kressuk from the Oak Creek Fire Department and Captain David Stecker from the Oak Creek Police Department.

### **Item Three: Approval Of Minutes**

Commissioner Koenig made a motion to accept the minutes 690 from our previous meeting on October 30, 2019. Commissioner Laskaskie seconded the motion. Upon roll call, the motion carried at 1801 hours.

### **Item Four: Review and Approve Assistant Fire Chief Selection Process**

The following action was taken as a result of the Closed Session meeting:


