MINUTES OF A REGULAR MEETING WATER AND SEWER UTILITY COMMISSION TUESDAY, NOVEMBER 12, 2019

ROLL CALL

Present at the 9:00 a.m. beginning were: Commissioners Wille, Siepert, Gehl, Richards and Cigale.
