**Waiver and Release**

The undersigned freely, voluntarily, and without duress executes this Waiver and Release under the following terms:

- The undersigned does hereby release and forever discharge and hold the Municipality harmless from any and all liability, claims, and demands, either in law or in equity, which arise or may or may hereafter arise from the undersigned’s activities with the Municipality.
- The undersigned understands that this Waiver and Release discharges the Municipality from any liability or claim that the undersigned may have against the Municipality with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Undersigned’s activities with the Municipality, **whether caused by the undersigned or by the negligence of the Municipality or its officers, directors, employees, agents, or otherwise**. However, the Municipality and the undersigned understand that the Municipality is not released from liability for harm incurred by the undersigned which results from the Municipality’s intentional or reckless conduct.
- The undersigned understands that the Municipality does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness to the undersigned.

**Activities**

The undersigned desires to engage in the activities related to **Jr. League Basketball**. The undersigned understands that the following activity may include running, jumping, throwing and catching, contact with aggressive participants that may or may not be within the rules for the activity, moving equipment such as balls, activity equipment and gear such as shoes and guards, activity facilities such as courts and buildings, that may result in concussions, broken bones, torn ligaments, muscle strains, sprains, cuts, bruises, fatigue, shortness of breath, fainting, muscle soreness, cardiac arrest, heat exhaustion, infection, and dislocation.

- The undersigned hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases the Municipality from any and all liability for injury, illness, death, or property damage resulting from the Activities and caused by the undersigned or by the negligence of the Municipality.

The undersigned does hereby grant and convey unto the Municipality all right, title, and interest in any and all photographic images and video or audio recordings made by the Municipality during the undersigned’s Activities with the Municipality, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

**Construction of Waiver and Release and Severability**

The undersigned expressly agrees that this Waiver and Release is intended to be as broad and inclusive as permitted by the laws of the State of Wisconsin, and that this Waiver and Release shall be governed by and interpreted in accordance with the laws of the State of Wisconsin. The undersigned agrees that in the event that any clause or provision of the Waiver and Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Waiver and Release which shall continue to be enforceable.
