

## Oak Creek Police & Fire Commission Meeting Minutes

### **Item One: Call Meeting To Order**

President Scott Koenig called the meeting of the Oak Creek Police and Fire Commission to order on Thursday, January 21, 2021 at 1800 hours the Oak Creek Municipal Court, 301 W. Ryan Road, Oak Creek, WI.

### **Item Two: Roll Call**

The following Commissioners were present: Alexa Alfaro, Jesus Carrillo, Scott Koenig and Jeff Sageser. Commissioner Genene Hibbler was excused. Also in attendance were Fire Chief Mike Kressuk and Assistant Fire Chief Michael Havey from the Oak Creek Fire Department.

### **Item Three: Approval Of Minutes**

Commissioner Koenig made a motion to approve, as amended, the minutes from our previous meeting (707) on December 10, 2020. Commissioner Alfaro seconded the motion. Upon roll call, the motion carried at 1802 hours.

Commissioner Carrillo made a motion to approve the minutes from our previous meeting (708) on December 17, 2020. Commissioner Alfaro seconded the motion. Upon roll call, the motion carried at 1803 hours.

### **Item Four: Convene Into Closed Session**

Commissioner Koenig made a motion to convene into Closed Session pursuant to Wisconsin State Statutes, Section 19.85(1)(c) to review and discuss firefighter candidates. Commissioner Carrillo seconded the motion. Upon roll call, the motion carried at 1803 hours. **Item Six: Action Taken**

The following action was taken as a result of the Closed Session meeting:

Commissioner Carrillo made a motion to approve the final offer of employment for firefighter candidate Andrea Sanchez, contingent on successful completion of a medical evaluation, with the effective date of February 1, 2021. Commissioner Koenig seconded the motion. Upon roll call, the motion carried at 1824 hours.



Commissioner Koenig seconded the motion. Upon roll call, the motion carried at 1825 hours.
