Oak Creek Recommended COVID-19 Safe Practice Guidelines

Recommended Safe Business Practices

Establish, to the extent possible, curbside pick-up to reduce in-store traffic and mitigate outdoor lines.

Consider establishing entry lines outside of the business with markings for patrons to enable them to stand at least six (6) feet apart from one another while waiting to enter. Businesses are encouraged to also use alternatives to lines, including allowing customers to wait in their vehicles for a text message or phone call and scheduling pick-ups or entries to the store.

Consider establishing one-way traffic in shopping aisles.

Increase standards of facility cleaning and disinfection to limit worker and patron exposure to COVID-19, as well as adopt protocols to clean and disinfect in the event of a positive COVID-19 case in the workplace.

Adopt policies to prevent workers from entering the premises if they display respiratory symptoms or have had contact with a person with a confirmed diagnosis of COVID-19.

Comply with Physical Distancing and Protective Measures outlined below.

Ensure indoor/outdoor air exchange rates meet the requirements per Commercial Building Code as designed and approved for proper ventilation. Allowing for increased outdoor air (i.e. opening windows) is recommended.

Recommended Physical Distancing and Protective Measures

Wear a mask or cloth face covering while indoors or in an enclosed space, other than a private residence, and other people are present in the same room or enclosed space.

Maintain physical distancing of six (6) feet between people not residing in a single living unit or household.

Wash hands with soap and water for at least 20 seconds as frequently as possible or using hand sanitizer.

Cover coughs or sneezes.

Know the symptoms of COVID-19 and get tested if you have any symptoms of illness.

Get vaccinated when you are eligible for the COVID-19 vaccine.

Follow other public health recommendations issued by State of Wisconsin Department of Health Services and the U.S. Centers for Disease Control and Prevention.
