To Request:

Variances from Section 17.0334, part of the Drexel Town Square Mixed Use Planned Development District General Development Plan and Regulating Plan, and Section 17.0706 related to the number of wall signs allowed per elevation, the number of ground signs allowed per street frontage, and maximum dimensions for proposed signs.

If granted, the variances would allow the applicant to install the following signs in addition to the permitted signs:

Wall Signs

North Elevation:

- One (1) 20'-2 1/16" x 4'-11 3/8"
- One (1) 11'-7 1/2" x 4'-0"

East Elevation:

- One (1) 11'-7 1/2" x 4'-0"

South Elevation of Emergency Addition:

- One (1) 13'-5 3/4" x 3'-11 1/16"

East Elevation of Emergency Addition:

- One (1) 7'-7 1/16" x 2'-8"

West Elevation:

- One (1) 24'-6 7/16" x 6'-0"

Ambulance Entrance Freestanding Canopy West Elevation

- One (1) 7'-11 3/8" x 1'-4 1/16"

Emergency Addition South Entry Canopy

- One (1) 5'-5 11/16" x 1'-3 5/16"
- One (1) 7'-8 9/16" x 1'-3 5/16"

Emergency Addition East Entry Canopy
