

## **Oak Creek Police & Fire Commission Meeting Minutes**

### **Item One: Call Meeting to Order**

President Scott Koenig called the meeting of the Oak Creek Police and Fire Commission to order on Thursday, June 2, 2022, at 1809 hours at the Oak Creek City Hall, 8040 S. 6th Street, Oak Creek, WI.

### **Item Two: Roll Call**

The following Commissioners were present: Jesus Carrillo, Genene Hibbler, Scott Koenig and Jeff Sageser. Commissioner Margo Franklin was excused. Also in attendance were Chief of Police David Stecker from the Oak Creek Police Department and Fire Chief Michael Kressuk from the Oak Creek Fire Department.

### **Item Three: Approval of Minutes**

Commissioner Sageser made a motion to approve the minutes from our previous meeting (729) on April 7, 2022. Commissioner Hibbler seconded the motion. Upon roll call, all Commissioners present voted aye, and the motion carried at 1810 hours.

### **Item Four: Election of Officers**

### **Item Five: Convene into Closed Session**
