

**MINUTES
LICENSE COMMITTEE
July 20, 2022 at 8:30 a.m.**

1. The meeting was called to order at 8:30 a.m.
2. On roll call, the following committee members were present: Ald. Kurkowski, Ald. Duchniak and Ald. Gehl. Also in attendance was Deputy City Clerk Christa Miller.
3. Ald. Duchniak, seconded by Ald. Gehl, moved to approve the minutes of 5/6/22. On roll call, all voted aye.
4. The Committee reviewed an application for Operator license submitted by Brittany J. Kehoss, 6563 W. Dodge Pl., Milwaukee, WI 53220 (Aldi). Ms. Kehoss was in attendance.

Deputy Clerk Miller advised the Committee of Attorney Karls' review and the reasons an Operator license may be denied. As noted in Sections 7.82 and 7.83 of the City's Municipal Code, an application may be denied if the applicant has been convicted of a felony or is a habitual offender. An application may also be denied if the applicant has been convicted of possession or delivery of a controlled substance in the five years prior to application.

Ms. Kehoss has been arrested and/or convicted of two alcohol-related offenses in the five years prior to application. Further, Ms. Kehoss has two convictions for Possession of a Controlled Substance in the five years prior.

Ms. Kehoss provided the Committee with background information in regard to the arrests/convictions. The Committee questioned Ms. Kehoss about her convictions and noted that the most current was from 2018, for which she was issued a citation and paid a fine.

Ald. Duchniak, seconded by Ald. Gehl, moved to grant the approval of an Operator license to Brittany Kehoss, 6563 W. Dodge Pl., Milwaukee, WI 53220 (Aldi). On roll call, all voted aye.

5. The Committee reviewed an application for Operator license submitted by Kristina Asselin, 2054 S. 29th St., Milwaukee, WI 53215 (Pick 'n Save). Ms. Asselin was in attendance.

Deputy Clerk Miller advised the Committee of Attorney Karls' review and the reasons an Operator license may be denied.
