MINUTES OF THE REGULAR MEETING CITY OF OAK CREEK PARKS & RECREATION COMMISSION June 16, 2022

1. Call Meeting to Order/Roll Call

Commissioner Theys called the meeting to order at 6:06 pm. The following members were present at roll call: Commissioner Beyer, Commissioner Bautch, Commissioner Thiel, and Alderman Guzikowski. Also present was Senior Planner Kari Papelbon, City Administrator Andrew Vickers. Chair Schreiber-Johnson arrived to the meeting at 6:11 pm. Commissioner Druckrey and Commissioner Krist were excused.

2. Approval of Minutes - May 5, 2022

Commissioner Bautch moved to approve the minutes of the May 5, 2022 meeting. Secretary Beyer seconded. All voted aye. Motion carried.

3. New Business

a. Proposal for Consideration – Review and recommendation of responses to the North Bluff Planning Study RFP.

Senior Planner Papelbon provided an overview of the proposal (see staff report for details).

City Administrator Vickers commended the Plan Commission for the great job they did in reviewing the objectives for this project. City Administrator Vickers provided background for this project, and why they are recommending Edgewater Resources.

Commissioner Theys stated that Chair Schreiber-Johnson arrived to the meeting and he will pass the Chair to her.

Senior Planner Papelbon stated that she was drawn to Edgewater Resources because of the experience and feasibility with permitting. They know the area, and they know what we are up against. Edgewater knows what they are doing and can tell us what will work and not work.

Alderman Guzikowski made a motion that the Parks and Recreation Commission recommend to the Common Council that Edgewater Resources be selected to create a study and plan of redevelopment of public recreational space for the City of Oak Creek North Bluff. Theys second. All voted aye. Motion carried.

Chair Schreiber-Johnson requested that they be advised of the results or advise them of when the Common Council meeting will take place.

City Administrator Vickers responded that this will be up at the next meeting which is being held this Tuesday, June 21, 2022.

b. Informational Item – Update on the Abendschein Park Pavilion project.

City Administrator Vickers stated that since their last report, some changes occurred:

- A reduction in the size of the building.
- The separation into another proposal for the splash pad and playground.
- Infrastructure.
- Redesign for outdoor space and year-round events.

The Abendschein bid will go out in July, the bid will be confirmed by Common Council at their August 16th, 2022 meeting, and construction is to begin sometime after Labor Day. City Administrator Vickers then discussed the 1.3 million fee shortage and how they were able to determine their financial goals, (see staff report for details).

Chair Schreiber-Johnson advised the commission that herself and former Zoning Administrator, Laurie Miller, were working to find a way to allocate some of the Parks Impact fees to cover the long-term vision and maintenance to help the Parks Commission better understand the needs of the Parks.

City Administrator Vickers acknowledged that they did not include the Parks Commission in some of this budget processes, then stated Interim Director, Matthew Trebatoski, of the Department of Public Works is working on a 5-year big picture plan.

Chair Schreiber-Johnson stated a matrix would be helpful to them to make better informed choices. As an example: This fence lasts 20 years and we are on the 18th year, so should this be considered for replacement.

City Administrator stated that not all maintenance items would be out of Park Impact fees.

Chair Schreiber-Johnson stated that would be good to know. On the matrix, as an example, the items in blue would be budgeted by the City, items in green would be paid for through the Parks Impact Fees.

Senior Planner Papelbon stated that they are working on the updates to Master Parks and Open Space Plan. The Plan would be organized per park and include the 5-year maintenance and replacement schedule, and also how these will be paid.

Chair Schreiber-Johnson stated that the amount of money spent on which park, in the past, would be helpful to the Commission.

City Administrator Vickers responded that they would have to do some financial forensic to determine what was spent. This is a good idea, and Jeff Wendt may already have something that they can use, and this could help in forecasting.

Commissioner Bautch stated a Parks Impact Fee report would be helpful to let them know how the money is being budgeted.

City Administrator Vickers stated that there is a big picture report for larger ticket items, but this is something they can look at and try to include.

Commissioner Theys stated the Abendschein Pavilion project is budgeted tight, and asked if there were any projected overrun costs written in the budget.

City Administrator Vickers stated that there is a program for contingencies for items like engineering. They projected an 8% construction escalation estimate.

Chair Schreiber-Johnson stated that the City does not have a donation policy and, therefore, they are not accepting donations. A "Friends of Oak Creek Parks" group, could get this off the ground, and people would donate for a beer garden.

City Administrator Vickers suggested that they allow naming rights to the beer garden pavilion but suggested that this could take away from a community feel.

Commissioner Theys thought something like that would take away from the ambiance of the community.

Secretary Beyer likes the donation ideas because it allows other groups who would like to volunteer, donate money or both, to participate.

City Administrators Vickers stated that this would help with the school's community hours.

Secretary Theys suggested the buy a brick and get their name on it for some of the build.

City Administrator Vickers responded that they don't know if these are the right kind of bricks to do this.

Chair Schreiber-Johnson responded that she wanted to save the name brick idea for the pier project. She thought they already received grant money for the parking lot and thought some type of policies were being written that would allow them to accept donations. She stated that if the project is getting expensive, why not have another year of traveling beer gardens, and ask people to donate towards the permanent beer garden. She thinks that there are plenty of people that want something like this, and would contribute to. Like they do for back to the future on the clock tower.

Andrew Vickers stated that there were people working on a donation policy, but they redirected them because of other priorities.

Planner Papelbon responded that there are other components to this, such as:

- The Arts Committee is considering the same thing.
- Volunteer employees are acting on this Committee and they are working on forming a Commission.
- Library
- Other parts of the City of Oak Creek

When working on the Parks policies, they then realized all of these components and overlaps. An executive decision was made that the Parks policies would be on hold.

City Administrator Vickers stated that they can reopen this process and try to unravel all of the components and overlaps and start to move forward.

Commissioner Bauch asked if there is any controversy over using the Parks Impact fees to pay for a beer garden.

City Administrator Vickers responded that the Parks Impact fees are paid by the developer and this is how they would approach that. They are not using a single dollar of the general funds to fund this project.

Senior Planner Papelbon stated that these funds will not only be used for the pavilion but will be used for other events in the park.

Chair Schreiber-Johnson suggested a Parks Budget 101. How do they have any idea that what they are approving affects the overall costs. Just a single page that explains last year, this year, etc. would help the Parks Commission be more strategic than it is.

Commissioner Thiel suggested that this is to help them understand what are they approving, where is the money going, and where is it not going.

City Administrator Vickers stated they do not have it by park. They will work on this. They use the Community Survey in how the residents see what Oak Creek is and will be. The survey helps for projecting what is being proposed.

Commissioner Bauer asked that they receive some type of report that would let them know the status of Common Council's review.

Senior Planner Papelbon suggested that they provide them with the Significant Common Council Report that provides status from Common Council.

This item was informational only and a vote was not required.

Senior Planner Papelbon announced the new City Zoning Administrator and Parks Commission is Jack Kovnesky.

4. Adjournment

Commissioner Bautch made a motion to adjourn the meeting. Alderman Guzikowski seconded. All voted aye. The meeting adjourned at 7:11 pm.


