#### 3. New Business

### a) Strategic Goal Setting – 2023

- o Live music/concert series.
- o Increase social media presence beyond Facebook.
- o North Bluff Redevelopment project is in the beginning stages.
- o Possibly relocating the CAFE event to the lakefront.
- o Collaborate with the South Suburban Chamber to have a "Sneak Peak Oak Creek" event.
- o 2023 Sponsorship campaign will be released by November 1, 2022.

### • b) Appreciation Event

 Laura informed the Commission that this will now be held at the Homewood Suites Creekside Crossing Conference Center in late September on a Wednesday or Thursday. The original idea to go to a Milwaukee Milkmen game was too like an event that the South Suburban Chamber was hosting.
