Who should I contact about my Property Taxes?

All 2022 Real Estate Property Taxes, as well as all Personal Property Taxes regardless of year, are currently being collected by our Villages and Cities. If you have any questions, you can contact the appropriate municipality as listed at the bottom of [this page](#).

All 2021 and older Real Estate Taxes are being collected by the County Treasurer. If you have any questions about these taxes, including *parcels with bankruptcy filings*, please call our office at 414-278-4033 before making payments.

Unpaid real estate taxes from 2018 and prior are eligible for tax foreclosure.

If no search results are returned, please broaden your search by selecting fewer criteria.

1. From the drop-down menu, choose if the property is a real estate or personal property account.
2. If searching for up-to-date ownership information, type in the current year. Tax information comes out in December, so enter the prior year if searching for tax information. Or leave it blank to bring up every year, going all the way back to 1995.
3. Select the City of Oak Creek from the drop-down menu to limit it to Oak Creek properties only. If left blank, it will bring up any property in the 19 Milwaukee County municipalities that fit the criteria entered.
4. Enter the parcel number if known, here.
5. Enter a last name to search if you have no other search information.
6. Enter the house number or street name to narrow down the search.
7. Click **Search**.

This will populate the bottom half of the screen with search results.

General Legal Values Taxes Special Extras

Use the drop-down tax year menu to toggle between different years.

The **General** tab has basic information about the parcel.

The **Legal** tab is where the legal description is found for filling out PSR's.

The **Values** tab is where the current assessment information is found. This is only updated once a year by the Assessor's office, and values are not finalized until after the Board of Review in June. Please contact the Assessor's Office with questions about values at 414-766-7069.

The **Taxes** tab shows taxes for the year and any payments that have been made. This is where a property tax summary report can be printed from. A tax bill can also be printed from this screen.

The **Special** tab shows any extra charges that have been added to the tax bill for the year. The most common special charge added is the advance storm water fee.

The **Extras** tab displays any related personal property accounts that are tied to the property.
