CITY OF OAK CREEK MILWAUKEE COUNTY

- 1. Mayor Allan Foeckler called the meeting to order at 7:00 p.m. On roll call, the following alderpersons were present: Ald. Jakubczyk, Ald. Bukiewicz, Ald. Toman, Ald. Scaffidi, Ald. - 2. The meeting began with the Pledge of Allegiance being said by all present.

4. PUBLIC HEARING HELD TO CONSIDER PROPOSED AMENDMENT TO SECTION 17.0308 OF MUNICIPAL CODE, LISTING TWO-FAMILY DWELLINGS EXISTING PRIOR TO NOVEMBER 20, 1995, AS CONDITIONAL USE IN RS-4, SINGLE FAMILY RESIDENTIAL ZONING DISTRICT.

A public hearing was held to consider a proposed amendment to Section 17.0308 of the Municipal Code, which would list two-family dwellings existing prior to November 20, 1995, as a conditional use in the Rs-4, Single Family Residential Zoning District (See Item No. 4 for action on this hearing).

5. PRESENTED AND ADOPTED: ORDINANCE NO. 2646, CREATING SECTION 17.0308(C)(10) ADDING A CONDITIONAL USE TO RS-4, SINGLE FAMILY RESIDENTIAL ZONING DISTRICT ALLOWING TWO-FAMILY DWELLING UNITS IN EXISTENCE PRIOR TO NOVEMBER 20, 1995.

Scaffidi, moved to adopt Ordinance No. 2646, creating Section 17.0308(c)(10), which adds a conditional use to the Rs-4, Single Family Residential zoning district that would allow for two-family dwelling units that were in existence prior to November 20, 1995, and to direct staff to apply for conditional use permits for those individual properties on behalf of those property owners that ask that this action be taken, with the understanding that the fee would not be assessed against the property owner.
