Message from the Health Officer

This report of the Health Department's activities during 2013 is presented in compliance with Wisconsin's Administrative Rule HFS 140.04(3)(a). I wish to thank the Board of Health for assuring that the core functions of public health are met and for their total support of our Level II Health Department.

The Oak Creek Health Department exists to protect the health and safety of the entire City of Oak Creek by Promoting Health, and Preventing Disease and Injury. Although many residents may not utilize our services directly, all have used our services indirectly. For example, public health is instrumental in safe food, clean air, pure drinking water, clean pools, childhood vaccines, and chronic disease risk reduction through the promotion of healthy behaviors. Here are some of the highlights in 2013 . . .

On January 17, 2013, the Board of Health unanimously voted to approve a restaurant summary sheet and begin posting license establishment inspections on the Oak Creek Health Department web site for the public to view. The inspection summary reflects the Critical Risk Factor violation observed at that time of inspection.

On March 19, 2013, a CDC evaluator and a U.S. Marshall came to the Health Department to conduct an on-site Local Technical Assistance Review (L-TAR). Many of our partners such as Mayor Scaffidi, Lt. J. Antisdel, Lt. D. Ashenhurst, Battalion Chief M. Kressuk, Dave Laehn, and all Health Department staff were in attendance. It is with great pleasure to announce that the Oak Creek Health Department's score was 99%, the highest score in the State of Wisconsin. All staff worked tirelessly in preparation for the L-TAR.

During 2011-2013, Molybdenum became an environmental issue for some residents with private wells. A Public Hearing was held on October 15, 2013, followed by the Council authorizing water main, laterals, and appurtenances in S. 10th Avenue and E. County Line Road, levying a special assessment.

Communicable disease continues to be a formidable challenger. In 2013, the Pertussis outbreak was losing some steam but continued throughout the year. Adults were and are still encouraged to get a booster Tdap vaccination for their protection and the protection of their young family members. Tuberculosis (TB) did not stop in 2012. In 2013, the Health Department investigated and managed another large TB case with daily direct observed therapy continuing for 6 months. The TB Dispensary, established in 2012, proved to be a benefit for residents who did not have insurance, assuring them access to medical care. New emerging communicable disease continues to be on the public health radar with constant surveillance throughout the City, State, Nation, and World. Communicable Disease has no boundaries.

We are pleased to provide you with this City of Oak Creek Health Department 2013 Annual Report.
