Background: This is the original roof that was installed when the building was built in 1989. The shingles on the current roof are at the end of their useful life. The roof has several leaks and the wind is starting to damage the current roof. We received only one bid for this project and that was from Alois Roofing and Sheet Metal. I contacted two other roofing firms that had pulled plans from our web site but did not submit bids. One stated that their firm is not certified to install the product we specified for the new roof. The other firm had too much work to take on this size job at this time. Alois Roofing and Sheet Metal is the same firm that put the new roof on fire station 3 last year, and I am pleased with the quality of their work.

Fiscal Impact: There is funding reserved for this work in the 2015 CIP budget.



**Background**: Nick Wimmer, Wimmer Communities, is requesting approval of a Certified Survey Map that will combine and reconfigure the parcels at 6871, 6881, 6881R, 6933, 6939, and 6955 S. 13th St. This CSM is related to the planned expansion of the Southfield Apartment complex.

Easements are missing from the CSM and must be included prior to recording the map. Comments from the Water and Sewer Utility indicate that water and sewer laterals at 6881 and 6939 must be abandoned at the main. Also, the sanitary sewer plan precludes the property from being divided in the future. Staff recommends that the applicants work closely with the Utility to address the concerns.

The Plan Commission has reviewed this request and has recommended its approval with the following conditions:







# Location Map 300 W. Oakview Parkway









# MINUTES LICENSE COMMITTEE Tuesday, May 26, 2015 at 9:00 A.M.

This meeting was called to order at 9:06 a.m.

Present were: Ald. Kurkowski, Ald. Verhalen, and Ald. Gehl. Also in attendance was Ald. Guzikowski, Assistant City Attorney Melissa Karls, City Clerk Catherine Roeske, Police Chief John Edwards, and Deputy City Clerk Christa Miller.

1. The Committee reviewed an application for Operator license submitted by Veronica Gibbs, 1509 Walnut St., South Milwaukee (Applebee's). Ms. Gibbs was in attendance.

On her application, Ms. Gibbs noted that she had no prior convictions on her record.

The police record check showed that Ms. Gibbs was convicted of Underage Alcohol Non-Driving, 7/21/2011, in Milwaukee.

Ms. Gibbs acknowledged the conviction and indicated that in 2013 when she applied for an operator license, she disclosed it. She further noted that she was unaware it should be listed on subsequent renewal applications, and therefore, the reason behind why it was not disclosed this time. Deputy City Clerk confirmed that when Ms. Gibbs first applied in 2013, she did disclose the conviction on her application.

Ald. Gehl, seconded by Ald. Verhalen, moved to grant an Operator's license to Veronica Gibbs, 1509 Walnut St., South Milwaukee (Applebee's). On roll call, all voted aye.

The Committee reviewed an application for Operator license submitted by Gina Montes, 7964 S. 15<sup>th</sup> Pl., Milwaukee (Fairfield Inn & Suites). Ms. Montes contacted the City Clerk's office prior to the meeting, indicating that she works during the day at Fairfield and would be unable to attend the meeting.

On her application, Ms. Montes noted that she had no prior convictions on her record.

The police record check showed that Ms. Montes was convicted of Retail Theft <\$100 Ordinance Violation, 3/25/10, in Greendale.

Ms. Gibbs submitted a letter to the License Committee on behalf of herself and in regards to this discrepancy. In the letter, she notes that the license is part of her employment requirement and that the conviction had happened over five years ago and recently had begun the process of having the conviction expunged from her record. Due to funds, she had not been able to complete the process and was not sure that it would appear on the police report.

Ald. Gehl, seconded by Ald. Verhalen, moved to grant an Operator's license to Gina Montes, 7964 S. 15<sup>th</sup> l., Milwaukee (Fairfield Inn & Suites). On roll call, all voted aye.

The Committee reviewed an application for Operator license submitted by Jason Wagner, 631 E. Pheasant Run, Oak Creek (Applebee's). Mr. Wagner was in attendance.

On his application, Mr. Wagner disclosed three OWI offenses (2/19/13, 12/12/13, and 2/4/14).

The police record check confirms these convictions.

Mr. Wagner acknowledged that he is a server at Applebee's. He would like to participate in Applebee's management program and that obtaining this license is a requirement of that program. He advised that he has been sober for over two years and that as a result of these convictions, he has had to comply with absolute sobriety, an AODA treatment program, as well as period urinalysis check and all have been completed favorably. He indicated that his drivers' license has been revoked and that he is currently in the process of having it reinstated. He further acknowledged that Applebee's does not allow any drinking by employees during work, or furthermore, on their off days, at the establishment.

The Committee discussed how with Mr. Wagner's three prior OWI convictions, all within the past 3 years, he would be considered a Habitual Offender and that could be grounds for denial. The Committee also discussed how it has been over a year since Mr. Wagner's last offense and of the requirement of the management program at Applebee's that an operator license be obtained.

Ald. Gehl, seconded by Ald. Verhalen, moved to grant an Operator's license to Jason Wagner, 631 E. Pheasant Run,, Oak Creek (Applebee's). On roll call, all voted aye.

The Committee reviewed a Reserve Class B Combination alcoholic beverage license for the period July 1, 2015 through June 30, 2016, for Hush, LLC dba Bootz Saloon & Grill, 8950 S. 27<sup>th</sup> St., Christina S. Clausen, Agent. Ms. Clausen was in attendance. Also in attendance was the owner of the property, Tom Tsopelas, 8435 Anna Ave., Wind Lake, WI and Roger Pyzyk, Attorney for the applicant,

Police Chief John Edwards spoke on behalf of Staff recommendations. Chief Edwards recommended non-renewal of the renewal license due to Code violations, particularly the noise complaints and the many calls for service that have resulted in the premises being declared a chronic nuisance per Oak Creek Municipal Code, Section 11.105(b)(2).

Chief Edwards acknowledged that in the three years that Bootz has been operating in the City, the Police Department has received numerous complaints, mainly for loud noise, as well as for traffic / parking, and that there has been no movement to rectify this situation prior to Attorney Pyzyk being hired to represent the applicant.

Attorney Pyzyk noted that on May 4, he met with Chief Edwards, Christina Clausen (applicant) and Soundproof Chicago to review options to alleviate continuing noise issues. Since that meeting, the applicant has contracted with Soundproof Chicago for purposes of noise abatement. Soundproof Chicago has proposed a brand new sound barrier wall on the south side of the building. The applicant has applied for this renovation permit.

Attorney Pyzyk indicated that the wall construction will cost approximately \$11,000, and construction is scheduled to commence on 7/13/15; however, Attorney Pyzyk has expressed that they will be requesting an earlier construction date. Construction is scheduled to last 3-5 days, possibly one week. Attorney Pyzyk has expressed that due to the time-frame of the renewal as well as the wall construction date, they would like to receive their renewal prior to going forth with the sound abatement wall.

Attorney Pyzyk acknowledged that his client would be willing to stipulate to 1) construct the sound abatement wall by 7/13/15 and 2) maintain in good repair the north-south fence to the east of the business if a renewal license was granted, and, if either of these conditions were not met, that they would not contest any revocation of the license as to these two issues.

Attorney Pyzyk noted that "no parking" signs on S. 26<sup>th</sup> Street may help the citizens on that street with overflow parking and loitering. Chief Edwards acknowledged that he would research that option and get back to Ald. Kurkowski regarding that item.

Assistant City Attorney explained that the options for the Committee included 1) granting a renewal Reserve Class B Combination alcoholic beverage license for 7/1/15 through 6/30/16, or 2) holding the item, including for the possibility of allowing for beginning non-renewal proceedings.

Ald. Kurkowski acknowledged that he would like to see the applicant be provided with the opportunity to correct the noise issue.

Ald. Gehl acknowledged that he would like to see if the applicant would be able to move up the construction date.

Ald. Verhalen proposed reducing the decibel level until such time that the License Committee can meet again.

Ald. Verhalen, seconded by Ald. Gehl, moved to hold action on the Reserve Class B Combination alcoholic beverage license for the period July 1, 2015 through June 30, 2016, for Hush, LLC dba Bootz Saloon & Grill, 8950 S. 27<sup>th</sup> St., Christina S. Clausen, Agent. On roll call, all voted aye.

Ald. Gehl, seconded by Ald. Verhalen, moved to grant alcoholic beverage license licenses for the period July 1, 2015 through June 30, 2016, with issuance subject to outstanding department approval(s), as follows as follows.
