Recommendation: The Personnel Committee has considered a request for a pay adjustment from the Municipal Judge. The Committee has also considered information provided by the Judge. The Personnel Committee recommends the Council approve Ordinance 2774 (attached) to establish the annual salary for the Municipal Judge for each of the four years of the term beginning May 1, 2016.

Background: Personnel Committee members reviewed the attached request and information from the Municipal Judge to consider an increase in pay for the position. The Municipal Judge serves a four year term. The current term ends April 30, 2016. According to State Statutes, pay for the position must be established by the Common Council through the adoption of an ordinance prior to nomination papers for the position becoming available to potential candidates. Nomination papers for the position will become available on December 1, 2015. Based on the Common Council's regular meeting schedule, an ordinance setting the pay for Municipal Judge should be completed no later than at the November 17th meeting.

Attached is an ordinance as recommended by the Personnel Committee to establish the annual pay and salary for the Municipal Judge beginning May 1, 2016. This ordinance reflects an increase of \$1,250 in each of the four years for the established term.

Fiscal Impact: None expected by this action. The Municipal Judge has adjusted the Municipal Court's budget request for 2016 to reflect no increase. The cost of any approved salary increase will be made up for by other line item adjustments.

AN ORDINANCE FIXING THE SALARY, WAGES AND ALLOWANCES FOR ELECTED MUNICIPAL JUDGE OFFICE AND POSITION FOR THE FOUR-YEAR TERM MAY 1, 2016- APRIL 30, 2020

The Common Council of the City of Oak Creek do hereby ordain as follows:

SECTION 1: There is herewith established the uniform rates of pay of those certain offices and positions in the City services under the control of the Common Council of the City of Oak Creek affecting non-union, management and miscellaneous personnel for the term listed above. The proper city officials are authorized and directed to make the required payments to those affected employees of the City pursuant to this ordinance.

SECTION 2: The Municipal Judge shall not be eligible for fringe benefits.

SECTION 3: AUTO EXPENSE. The Municipal Judge shall be paid the rate allowed under the most current IRS regulations and per the Travel Policy.

In order to qualify for the above mentioned auto mileage and/or allowance, the officials designated must provide proof of insurance by a reasonable insurance company for bodily injury and property damage liability within minimum policy limits of \$250,000/\$500,000/\$25,000. In order to receive reimbursement, a Declaration of Coverages page stating the policy limits shall be provided annually by January 31 or upon policy renewal to the Personnel Office.

SECTION 4: VALIDITY. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect the validity of the remaining portions thereof. The Common Council of the City of Oak Creek hereby declares that it would have passed this ordinance and each section, subsection, clause, phrase or portion thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses, phrases or portions thereof, may be declared invalid or unconstitutional.

SECTION 5: All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

SECTION 6: This ordinance shall take effect and be in force upon its passage and publication and shall apply as of May 1, 2016, except where otherwise noted.

Re: Salary increase for position of Municipal Judge

Personnel Request

The salary of Municipal Judge is \$16,323. The proposed 2016 budget for the Municipal Court includes an increase of the judge's salary by \$5,000 to \$21,343.

Explanation

The Municipal Court is a co-equal branch of government as opposed to a department of the City of Oak Creek government. Wis. Stat. 755.01. As such, the elected position of Municipal Judge is one of the highest elected officials in the City of Oak Creek. The salary of the Municipal Judge is set by the municipality's governing body because the court is maintained at the expense of the municipality. The attached chart reveals that salary for the position of Municipal Judge is severely lagging behind counterparts in surrounding and comparable municipalities. See attachment.

Additionally, Court operations have grown over the past 10 years. The number of citations has increased. The court now needs 2 City prosecutors to handle the caseload, and the Court has added 1 part-time clerk to assist in processing the citations. The Municipal Judge's productivity has increased to meet the needs of the court. As a result of this increased workload, there has been an increase in court revenues. For example, in 2007, the Court processed 5,444 cases. In 2014, the Court processed 6,734 cases. Court revenues grew from \$376,360 in 2007 to \$410,685 in 2014.

Finally, the Municipal Court's proposed 2016 budget has implemented significant efficiencies. Therefore the proposed increase in wages was set off by concomitant reductions in expenses so there will be no overall increase in the court's 2016 budget from 2015.

Background: The acquisition (authorized under Resolution No. 11616-050515) of real estate and easements is necessary for 5th Avenue project, a new road extension from the intersection of STH 100 (Ryan)/STH 32 (Chicago) to 5th Avenue/Ryan Road. The acquisition costs have been determined to be acceptable by the affected property owners. Single Source, Inc. is handling all of the real estate acquisitions for the project. They are the sub-consultant for the City's road designer, Strand Associates. The City must acquire right-of-way (FEE); and highway, permanent, and/or temporary easements across eleven parcels.

The City has approved eight acquisitions previously. These two represent the last of the private property acquisitions required for the project.
